Agricultural Building Display
COUNTY, COMMUNITY AND ORGANIZATION

1. Refer to “**Notice to Exhibitors**” rules 2&3 for entry due dates.
2. All booths must be completed by 8 p.m., WEDNESDAY.
3. All Decorative material used in construction of booths must be fireproof.
4. Feature exhibits (booths) shall be limited to one entry by or for a county, community, organization or non- commercial entry in this department.
5. Exhibits must be maintained for the duration of the Fair.
6. Size of booths: 100 square feet (10' x10').
7. All booths will be displayed in the Ag Building.

Division 300 - Feature Booth

Class 01 Agricultural Organization Booth – Limited to those which display the advantage and the diversity of the agricultural products grown in the county, community or area represented. The products displayed must have been produced by members of the community or organization within the area represented.

A typewritten or printed list of the products contained in the booth arranged alphabetically, or separated by classes, must be attached to (or be a part of) the exhibit or the percentage of the score earned for variety will not be allowed.

Class 02 County/County Organization Feature Booth – Should display an agricultural product, process or procedure of the area represented in such a manner as to most attractively inform the public of the value, desirability and interest to the consumer, producer and community to be found in the subject being featured.

Class 03 Community/Club Organization Feature Booth – Should display a product, process or procedure of the area represented in such a manner as to most attractively inform the public of the value, desirability and interest to the consumer, producer and community to be found in the subject being featured.

Division 301 - One Family Farm Feature Booth Approximately 32 square feet. Entry for families of the district or county in which the fair is held.

Class 01 One Family Farm Feature Booth – All products entered must have been produced within the county or district during the last year by the exhibitor or member of his family on land

farmed by exhibitor. Products entered as part of the exhibit will not be eligible for individual product premiums.

Division 302 – Business/Artists Feature Display Booth

Class 01 Business/Artists Feature Display Booth

1. Feature Display Booths are to be used for displaying and advertising art or business commodities for artists/businesses that are unable to attend commercial booths the entire 4 days of the Fair. Exhibitors may display business cards or contact information.
2. All booths must be completed by 8 p.m., WEDNESDAY.
3. All Decorative material used in construction of booths must be fireproof.
4. Feature exhibits (booths) shall be limited to one entry per exhibitor.
5. Exhibits must be maintained for the duration of the Fair.
6. Size of booths: 100 square feet (10' x10').
7. All booths will be displayed in the Junior or Ag Building, as space permits.
